HARP General Assessments	Guide that reviews how to track HARP activities in CareManager. These General Assessments are what will feed the HARP Report Card data received monthly.	CHC Resource Page, under HARP
Preliminary POC LOSD-R	Required form completed for access to HCBS services after the Eligibility Assessment is completed and entered into UAS (in the Health Commerce System); must be submitted to the MCO to request authorization for any HCBS services being pursued.	
HCBS CORE Referral Form	Universal referral form for CORE and HCBS Services; goes directly to CORE/HCBS provider (after the LOSD is received back from the MCO for HCBS services).	
CORE LPHA Recommendation Form	Form submitted with the referral for CORE services. This form requires an LPHA sign off; if you do not have an LPHA on staff the referral can be submitted without this form.
