### From the Director's Desk

In April 2013, the National Council of State Boards of Nursing raised the passing standard for the licensure exam (as they do every few years). There was an unexpectedly precipitous decline in the first time pass rates all over the country, which resulted in the national mean pass rate dropping from 90.3% (2012) to 83.0% (2013). I am very pleased to report that our graduates continued to perform at the top – our pass rate stayed steady at 90.2%! Our PN graduates are also doing well on NCLEX – the PN pass rate for 2013 was 95%!

We continue to plan for the move to the St. Mary's campus. I have been meeting regularly with the architects and construction crew, but nothing is finalized yet and there is no firm date for the move. I expect it will be either in December 2014 or summer 2015. I have been very clear that it would be disruptive to the students and the educational program to move in the middle of a semester. # **Sheldon Committee**

The Doris Sheldon Fund was established in 1986 by a gift from Doris Sheldon Collins and her husband Robert to the Samaritan Hospital School of Nursing (SON) Alumni Association Charitable Foundation. The fund was established to provide financial assistance based on need to graduates of and others associated with the Samaritan Hospital SON in their retired or mature years. The intent is to help those with limited resources enjoy a fuller life, particularly when they are no longer gainfully employed.

Awards from the fund are distributed biannually in June and December. The committee will be meeting in May for distribution of June awards. ### Seber Committee

The William F. and Josephine H. Seber Scholarship Fund was created in 1973 through funds left to the Samaritan Hospital School of Nursing Alumni in the last will and testament of Sarah Etola Peck. The will stated this fund is to be used to provide scholarships for the study of nursing to young women who desire to become registered nurses or to registered nurses who desire graduate study in nursing. These funds are only eligible to male applicants seeking graduate study in nursing. In addition, the applicants must be in good academic standing and supply proof, such as a copy of grades for the semester for which they are applying, with their application. Furthermore, registered nurses seeking funds for graduate assistance must be in good standing (dues paid or waived according to association rules) with the Alumni Association.

This Spring Seber awards will be awarded at the end of the semester to ensure compliance with Seber Fund rules. The applicants must be in good academic standing and supply proof, such as a copy of grades for the semester for which they are applying, with their application. Please see the rules of the Seber Fund attached to the application. If you are not compliant with established fund rules you may not be eligible for future awards or you maybe required to return funds received. Applications for the Seber Fund may be found online via the St. Peter's Healthcare Partners website, under Samaritan Hospital School of Nursing Alumni Association. We encourage anyone eligible to apply.

## **District Liaison:**

This committee acts as a liaison between the Samaritan Alumni Association and the Capital District #9 of the New York State Nurses Association (NYSNA). All bills proposed in the NYS Legislature and newly enacted laws and other pertinent information affecting the nursing profession are brought to the attention of the alumni membership.

All District #9 meetings are held on the first Thursday of the month (October, December,

February, April, and June) at the Century House The cost is \$32.00 for members and \$37.00 for non-members. Continuing Education certificates are made available to those attending.

### Status on NYSNA, ANA, and District #9

In 2011, the NYSNA Board of Directors made a decision to end its long time affiliation with the national organization (ANA). This was made official October 2012 at the annual meeting of NYSNA. Since this decision, NYSNA has become more actively involved in collective bargaining. In December, ANA-New York was formed and accepted by the ANA as its state affiliate.

As a result of this disaffiliation with ANA, the association (District#9), lost the availability of CE's from NYSNA. District #9 was able to apply for CE's from the Georgia Nurses Association which will expire in 2014.

District #9 consulted legal council regarding several issues regarding tax exempt status, confusion as to the actual name of the organization, and accurate number of actual members. The law firm established that District #9 is a separate legal entity from NYSNA. Our name is Capital District Number Nine, New York State, Nurses Association, Inc. If we would like to keep the name, we need to file an amendment with the Department of Education.

At a special meeting held on September 12, 2013, District #9 voted to disassociate from the NYSNA. The new name is still pending at present.

### NYSNA priority legislation for 2013 Legislative Session

#### 1. Safe Staffing Ratios

Establish minimum nurse-to-patient ratios in all health care facilities. The bill was agreed upon by labor unions in NewYork State that represent registered nurses. It currently is in the Assembly Ways and Means Committee and Senate Finance Committee.

#### 2. Educational Advancement for RNs:

Would require registered professional nurses (RNs) to attain bachelor's degree in nursing within ten years of their initial licensure, while "grandfathering" nurses already in practice and nursing students already enrolled. Currently in the Ways and Means Committee of the Assembly.

#### 3. Safe Patient Handling:

Requires all facilities implement a safe patient handling policy to reduce the manual lifting of patients by direct care staff. Currently in Assembly Health Committee and Senate Rules Committee.

#### 4. New York Health:

Would create a comprehensive system of universal healthcare coverage for all residents of NY State regardless of age, income, health or employment status

#### 5. Educational Advancement for RNs:

Would require registered professional nurses to attain a bachelor degree in nursing within 10 years of their initial licensure, while "grandfa-thering" nurses already in practice and nursing students already enrolled.

- 6. Ban on Mandatory Overtime for RNs in Home Care
- 7. CNS Title Protection and Certification

#### 8. Mandatory Contiuing Education for RNs:

Would require 45 hours of continuing education in order to re-register every three years, to practice as a registered professional nurse.
